



2020 Patriots Season Ticket Raffle Prize Details

What does the package include?

The package consists of 2 persons to attend the All Pro Celebrity Tailgate Party for all the home games (*does not include preseason or postseason games*) for the upcoming 2020 N. E. Patriots at Foxboro. This includes not only the pregame party and postgame party but parking in private lot as well. The recipients will also receive 2 game tickets for each home game.

What is the tailgate?

Your winners will receive all the amenities that go with our exclusive party; open bar prior to the game, entertainment, celebrities, great food, linen dressed tables, wide screen HDTVs through out the tent, and much more. The postgame party consists of everything mentioned before without the open bar.

When does the party start?

The tent opens 3 hours before any home game and usually ends an hour to 2 hours after the game.

Where are the seats for the game?

The winners will be provided seats within the 1st and 2nd tiers of the stadium. These are great seats and not “nose bleeds”.



OFFICIAL RULES: *By participating, entrants agree to be bound by these Official Rules and by the decisions of Learn to Cope, Inc., which shall be binding and final as to all matters related to the Raffle. The Raffle is subject to all applicable federal, state and local laws.*

SPONSOR: *Learn to Cope, Inc., 4 Court Street Taunton, MA 02780. Nonprofit Tax ID Number 26-0236431.*

NET PROCEEDS: *All net proceeds of the Raffle will benefit Learn to Cope, Inc., a 501(c)(3) public charity (hereafter known as "Sponsor" or "Learn to Cope") and its mission as a non-profit support network that offers education, resources, peer support and hope for parents and family member coping with a loved one addicted to opiates or other drugs. All of the net proceeds from the raffle proceeds will be dedicated to Learn to Cope's charitable purposes.*

THE PRIZE: *The prize package consists of 2 persons to attend the All Pro Celebrity Tailgate Party for all the home games (does not include preseason or postseason games) for the upcoming 2020 N. E. Patriots at Foxboro. This includes not only the pregame party and postgame party but parking at our private lot as well. The recipients will also receive 2 game tickets for each home game. The approximate value of the prize package is \$13,000.*

ELIGIBILITY TO ENTER: *Raffle tickets may be purchased by only by person 18 years or older in accordance with these Official Rules. Raffle tickets may NOT be purchased by anyone under the age of 18, regardless of location or method of purchase.*

Raffle tickets are available for purchase in person at the Learn to Cope office (during business hours) or through a Learn to Cope staff member. This Raffle is void wherever prohibited by law.

No employee of the organization or their immediate family members may purchase tickets to the raffle or win the prize. "Immediate family members" means spouses, parents, grandparents, children, grandchildren, and siblings (and any of their respective spouses) of an Ineligible Party.

PURCHASING RAFFLE ENTRIES: *The price of Raffle tickets will be \$100 each. There are no discounts or complementary Raffle tickets. Raffle tickets will be available for purchase in person by eligible persons (see "ELIGIBILITY TO ENTER" above) at the Learn to Cope Office or through a Learn to Cope staff member starting on December 17, 2019, through July 23, 2020 (or until the maximum number of Raffle tickets are sold out, whichever comes first). Eligible patrons who purchase their Raffle tickets must agree to the terms and conditions. Official Rules are available at Learn to Cope, on and other points of sale and should be read before Raffle ticket purchase.*

All purchasers of Entries must provide their names, addresses, telephone numbers and (if available) e-mail addresses at the time of purchase.

Sponsor shall be the sole judge of the validity and eligibility of all Entries. All Raffle Ticket purchases shall be final, and no refunds or replacements will be issued by Sponsor. Official Rules are available on and at Learn to Cope and should be read before Raffle ticket purchase. Based on Sponsors determination, Raffle tickets purchased by individuals and through means that are not in compliance with these rules may be considered void and ineligible for the Prize. To be valid, all raffle Entries must be purchased no later than July 23, 2020 No portion of the Raffle ticket price may be deducted as a charitable contribution for U.S. federal income tax purposes.

MAXIMUM NUMBER OF RAFFLE TICKETS: *A maximum total of 300 Raffle Tickets will be sold. If 300 Raffle tickets available are sold before July 23, 2020, the Raffle shall be deemed "sold out" and no additional Raffle tickets will be sold. If the Raffle is sold out earlier than July 23, 2020 the Drawing will still occur on July, 24, 2020 stated in these Rules. There is no minimum number of Raffle tickets that must be sold.*

ODDS: *The odds of winning a Prize depend on the number of eligible Entries received. If the maximum 300 Raffle tickets are sold, the odds of winning for each Raffle ticket are 1 in 300. If less than the maximum Raffle tickets are sold, the odds of winning will be greater.*

RESALE OF RAFFLE ENTRIES: *Purchasers of Raffle tickets, whether purchased at Learn to Cope or other designated locations may not re-sell their Raffle tickets to other parties, and may not knowingly give such Raffle tickets away to others for the purpose of allowing those other parties to re-sell such Raffle tickets. All Raffle tickets which have been resold in violation of these Official Rules shall be void.*

The Raffle is being conducted pursuant to a raffle permit issued to Sponsor by the City of Taunton.

DRAWING: *The winner will be selected in a random drawing from eligible entries received (the "Drawing"). The Drawing will be held July 24, 2020.*

SELECTION AND NOTIFICATION OF WINNER: *On July 24, 2020, the Sponsor will select the winner by random drawing from all eligible entries. The owners of eligible entries need NOT be present in person at the Drawing in order to win. The Sponsor will contact the purchaser-of-record of the winning entry (the "Winner") using the information provided on the winning entry promptly after drawing, to notify him or her that he or she is the Winner.*

The Sponsor reserves the right to verify the eligibility qualifications of the Winner and to confirm that the Winner is not otherwise in violation of these Official Rules as determined in Sponsor's sole judgment. If for any reason whatsoever the foregoing requirements are not satisfied or if Sponsor is unable for any reason to identify the holder of the winning Raffle ticket or to contact the Winner, or in the event the Winner does not accept the prize, then the Prize will be deemed forfeited and, at Sponsor's sole discretion, an alternate Winner will be selected. The Winner will be contacted regarding fulfillment of the prize within four (4) weeks of the final winner determination and validation.

TAXES: All federal, state and local income taxes are the sole responsibility of the Winner. The taxable value of the Prize may be treated as ordinary income to the Winner for U.S. federal and state income tax purposes. Learn to Cope, Inc. is not responsible for the Massachusetts state sales tax, U.S. federal income withholding, and/or Massachusetts state income withholding taxes. These taxes are the sole responsibility of the winner.

GENERAL CONDITIONS: The Released Parties are not responsible for: (1) Entries which are stolen, lost, damaged, illegible, given away or no longer in the purchaser's possession, (2) Entries that have been or may have been tampered with or re-sold in violation of these Official Rules; or (3) any other errors of any kind, whether human, typographical, printing, mechanical, or electronic in nature, which relate to or are connected with the Raffle (collectively, as described in clauses (1) through (3), "Errors"), including without limitation Errors in Raffle-related materials or in the administration of the Raffle, such as Errors in processing Entries, identifying the Winner, or announcing or delivering the Prize.

RELEASE OF LIABILITY: Entrants, by participation in the Raffle, agree that the Sponsor, and their parents, affiliates, subsidiaries, partners, and advertising and promotion agencies, and all of their respective officers, directors, employees, representatives, shareholders, members, consultants and agents (collectively, the "Released Parties") will have no liability whatsoever for, and shall be held harmless by entrants against, any liability for injuries, losses, cost, expenses or damages of any kind, including damages for death, personal injury, property damage or property loss, or other harm resulting from, whether in whole or in part or directly or indirectly, participation in this Raffle or the acceptance, possession, misuse or use of any Entry or Prize, rules and their application thereof, all means of Raffle ticket sales, Raffle process, and/or winning Raffle ticket selection.

By purchase of a Raffle ticket or by redemption of a Raffle ticket for the Prize, the ticket holder agrees that: A) The Sponsor reserves the right to void any ticket that it deems tampered with, resold or purchased by an ineligible party; B) Resale of raffle tickets is not allowed and C) Raffle tickets may not be refunded.

COPYRIGHT: All Raffle materials are copyrighted by Sponsor, and may not be copied, reproduced or used for any purpose without Sponsor's express prior written consent.

GOVERNING LAW; SEVERABILITY: The Raffle and these Official Rules shall be subject to and governed by the laws of the Commonwealth of Massachusetts. If a court of competent jurisdiction finds that any provision of these Official Rules, or their application to a particular person or circumstances, is invalid or unenforceable to any extent, then the remainder of these Official Rules, and the application of all of these Official Rules to other persons or circumstances, shall not be affected by that determination, and shall remain enforceable to the fullest extent permitted by law.
